SOME ASPECTS OF QUICK-SEARCH ACTIVITIES

The tasks of operational-search activities related to the fight against crime are solved by conducting operational-search activities. Nevertheless, the law"on operational-search activity "does not have the concept of"operational-search activity". This now leads to a different interpretation of the Operational-Search event by scientists and operational staff of the field.

In particular, scientists have issued a different tariff for a quick-search event. In Particular, A.No, it's not.Shumilov noted that, according to the law on operational-search activity, it is a search action aimed at achieving the objectives of the subject (operative employee, facilitator, etc.) directly carrying out operational-search activities and obtaining the information necessary for solving operational-search activity tasks.

A.E. And Chechetin described as follows: operational-search action is an action aimed at directly identifying and using the forces necessary for the solution of operational – search activity tasks in accordance with the requirements of normative legal acts by authorized entities established by the law on quick-troubleshooting activities, together with transparent means and methods, mainly conducted using non-standard means and methods.

N.Y.Zubov and B.V.Nikolyukas, on the other hand, defined the Operational-Search event as a structural element of operational-search activity, consisting of a system of interrelated actions aimed at solving specific tactical tasks.

When developing a description of a quick-search event, it is necessary to pay attention to its specific signs. Scientists have a number of views on the signs of Operational-Search events.

In Particular, A.E.According to chechetin, the signs of operational-search activities are as follows: the fact that operational-search activities are consolidated by law; the possibility of conducting operational-search activities only by authorized entities; the fact that operational-search activities are carried out strictly in accordance with the requirements established by normative-legal acts; the fact that operational-search activities are used mainly by; the purpose of operational-search activities is that it focuses on the direct identification and use of the actual information needed to solve the tasks of the quick-troubleshooting activities.

In addition to the comments expressed by Chechetin, it is possible to correctly say that their views on the signs of the rapid-search activities. However, despite this, they are not complete. Because, which is typical for quick-search activities, namely the signs associated with the fact that operational-search activities are a component of the tqf, as well as the conduct of operational-search activities on the basis and conditions established by law, have remained unnoticed. These signs should be taken into account when giving a description.

S.I.Zakharsev operational-search activities included the following: Operational-Search event is an integral part of operational-search activities; Operational-Search event refers to the activities of state bodies; Operational-Search event is conducted directly by the bodies and officials specified in the law on the quick-troubleshooting activities; Operational-Search event is aimed at solving the tasks of operational-search activities directly; Operational-Search event is; the organization and tactics of the Operational-Search event should be considered a state secret; the purpose of the Operational-Search event is to meet the moral and ethical requirements .

For example, the opinion that operational-search activities should refer to the activities of state bodies is not a sign that is characteristic only of operational-search activities. Because, there are a number of other types of activities that are not related to the operational-search activities of state bodies. It is also difficult to agree with the idea that the purpose of the Quick-Search event must meet the spiritual and moral requirements. The purpose of conducting operational-search activities is the solution of the tasks of the quick-troubleshooting activities. The functions of the quick-troubleshooting activities are primarily aimed at protecting human rights,

freedoms and legitimate interests. From this it can be seen that the mark on the fact that instant-search activities are aimed directly at solving the tasks of instant-search activities, covers the fact that the purpose of instant-search activities must meet the spiritual and moral requirements. At the same time, the idea that the organization and tactics of a quick-search event will be considered a state secret is correct. But this is also not a sign that is typical only for quick-search events. According to the law on the storage of state secrets, other information also constitutes state secrets. Therefore, we do not have to include it in the series of characters that are characteristic of quick-search events, and focus the main attention on it when describing quick-search events.

V.G.Karimov included in the characteristics of the TRNC the following: operational-search activities as a component of the tqf; the fact that operational-search activities are established by law; the purpose of conducting operational-search activities is the fulfillment of the functions of the quick-troubleshooting activities; the implementation of operational-search activities only by subjects with special powers; the conduct of operational-search activities according to V.G.That's what we can say with the addition of Karimov's opinion. It is indicated that the purpose of conducting operational-search activities by him is the fulfillment of the tasks of the quick-troubleshooting activities. In our opinion, this view is general, it is necessary to clarify it more clearly. Because the functions of the tqf are very wide coverage. Therefore, it is worthwhile to say that it should be aimed at identifying, obtaining and using the information necessary for the purpose of solving the tasks of operational-search activity. In our opinion, it is necessary to include among the characteristic signs of operational-search activities by analyzing the above-mentioned definitions of scientists and their views on specific signs of the TRNC, as well as the results of research and practical experience:

- 1. The fact that the TRNC is strengthened by law.
- 2. Only authorized subjects of operational-search activities are allowed to conduct operational-search activities .
- 3. Operational-search activities are conducted on the basis and conditions established by law.
- 4. Operational-search activities are carried out in accordance with the requirements established in the departmental normative-legal documents of the bodies carrying out operational-search activities.
- 5. Quick-search activities are conducted mainly through the use of non-proprietary tools and methods in combination with transparent tools and methods.
- 6. The purpose of conducting operational-search activities is the identification, retrieval and use of Criminal Information and other information to solve the tasks of operational search activities established in Article 4 of the law on quick-troubleshooting activities.
- 7. In conducting operational-search activities, Information Systems, video and audio recording, film-and photography tools, as well as other technical means that are safe for the life and health of a person, property of legal entities and individuals, the environment are used.
- 8. Participation of relevant specialists in operational-search activities.

On the basis of the general requirements of the law and the theory of operational-search activities, as well as the reasons given by scientists to the quick-fixes events and its signs, the tqt can be formulated as follows:

operational-search activity is a set of actions carried out by authorized entities in accordance with the law on operational-search activities in support of transparent and non-transparent power, means, methods for the direct identification, retrieval and use of information necessary for the purpose of solving operational-search activity tasks on the grounds and conditions established by law".

In conclusion, it is necessary to introduce the concept of operational-search activity into the law"on operational-search activity". When developing the concept, it is necessary to take into account the above signs. Ignoring the characters can have a negative impact on developing the concept of a quick-search event. And the existing drawback in the concept, in turn, is the fact that certain shortcomings in the conduct of events are avoided by the practicing personnel.
