## DEVELOPMENT OF INDUSTRY IN GALLAARAL

Gallaaral district is a district of Jizzakh region. It was founded on September 29, 1926. Until 1931 it was called Yangikurgan district. It is located in the western, south-western part of the region. It is bordered by Forish in the north, Jizzakh in the east, Bakhmal in the south, Samarkand region in the southwest and west.



The central and western part of the district consists of plains, the northern and north-western parts - hills, high hills and mountains. It is bounded on the north by the Nurata Range and on the east by Mount Molguzar. Most of the district is flat, rising from 350,400 m to 1,600–1900 m north of its central part. The plain extends to the foothills of Mount Nurata. Minerals lead, zinc, gold, tungsten. There is sand, gravel, gypsum, granite, limestone and various other building materials of local significance, and there is a source of healing mineral water. The vegetation period is 240 days. The soil consists of yellow soil, lyoss. The soils of the hills in the central and northern parts are gray, light gray, typical gray soils formed on lyoss. There are many ravines and ravines. The Sangzor River flows through the district. Agriculture includes horticulture, horticulture, viticulture, and animal husbandry (including karakul).

There are general education, children's music schools, vocational colleges, the district central library, a house of culture, club facilities, a memory park. There are stadiums, gyms, sports grounds and other sports facilities. The district's central hospital, polyclinic, maternity hospital, pharmacy and other medical facilities serve the population. There are buses and minibuses from Gallaaral to Tashkent, Samarkand, Jizzakh and other cities. The Tashkent-Samarkand electric train passes through the city. There are about 90 general education schools, children's music schools, vocational colleges, the district central library and its 33 branches (244 thousand copies of works), 11 houses of culture, 15 club establishments. "Golden Spike" singing and dancing, "Gashtak" folklore and ethnographic groups. There are stadiums, gyms and other sports facilities. The district has a central hospital (520 beds), 4 polyclinics, a maternity hospital, 55 obstetrics and feldshers,

10 rural outpatient clinics, and pharmacies. The Greater Uzbekistan tract and railway pass through the district. Buses run from the district center to Tashkent, Samarkand, Jizzakh, Bakhmal, Gagarin, Pakhtakor and Dustlik. The Tashkent-Samarkand electric train will pass through the district.

Gallaorol is a city in Gallaaral district of Jizzakh region (since 1973), the center of the district. transport station. 30 km west of the regional center (Jizzakh). Tashkent-Samarkand railway, on the side of the Greater Uzbekistan tract. Population 23 thousand people (2005). There are ginning, brick, repair of agricultural machinery, milk processing plants, poultry factory, MTP, construction companies, car factories, farmers' markets, trade, cultural and consumer services. small and medium enterprises, micro-firms, joint ventures.

In Gallaorol district there are Marjonbulak and Koytash tungsten-molybdenum deposits, fruit canning, wine production enterprise, poultry joint-stock company, automobile plant, MTP, milk processing, repair of agricultural machinery, cotton ginning, brick factories. There are about 230 firms, medium-sized businesses, small businesses and micro-firms. There are joint ventures "Gallaorol - Jordan", "Gallaorol - Turkey", "Gallaorol - Belogorsk", "Vollastonit" (in Koytash).

The soil of the district is rich in various minerals - lead, zinc, gold, tungsten. There are also sand, gravel, gypsum, granite, limestone and other building materials of local importance. There is a source of healing mineral water in the district. The climate is sharply continental, summers are dry, winters are cold.

According to the Investment Program approved by the decisions of the Hokim of Jizzakh region No. 66 of 25.02.2020 "On measures to implement the regional investment program in Jizzakh region for 2020-2022" and No. 144 of 03.04.2021 The project of establishing a preschool educational institution by Asl Yangi Hayot LLC was planned to be launched on 01.12.2020 in Alamli mahalla of Gallaorol district. Currently, the building is 85% finished and exterior and interior decoration works are underway and will serve the younger generation.

According to the Investment Program approved by the decisions of the Hokim of Jizzakh region No. 66 of 25.02.2020 "On measures to implement the regional investment program in Jizzakh region for 2020-2022" and No. 144 of 03.04.2021 The project for the establishment of a private clinic and shopping center by Grain Island LLC is planned to be launched on 01.12.2022 in Dustlik mahalla of Gallaorol district. Currently, 70% of the work has been completed at the facility and the facility will be fully operational by 2023 and will serve the population.

According to the minutes of the meeting of the Cabinet of Ministers dated 11.04.2019 No 24 / 1-3063, the project for the production of automobiles and components (Phase I) is included in the Investment Program by ADM Jizzakh LLC. The Jizzakh Free Economic Zone and the Small Industrial Zones Administrative Council have allocated 30 hectares of land for the project on March 17, 2020. The first phase of the project was launched on December 2, 2012 and created 260 jobs. Phase II. In accordance with the Resolutions of the President of the Republic of Uzbekistan dated 28.12.2020 No. PQ-4937 and 30.12.2021 No. PQ-72, the project for the production of automobiles and components of ADM Jizzakh Limited Liability Company (Phase II) is included in the Investment Program ADM Jizzakh LLC in cooperation with KIA Motors has developed a network schedule for the project for the production of KIA cars, their components and car seats and submitted it to the regional Department of Investment and Foreign Trade. The company plans to produce an average of 50-100 thousand Lada, KIA and Renault cars a year. By 2023, exports are planned to be directed to foreign countries.

In addition, Sodda Tomato Canning LLC is a foreign company, AGRO NIVAS FOOD EXPORT LLC is a joint venture, MA-IL-RIS JV is a joint venture. Limited Liability Company Joint Venture, Granite Hill Limited Liability Company Joint Venture, Agro Bakhmal Limited Liability Company Joint Venture also serve the population.
